## A Note from the President and Founder of STR-STH:

Sadly the "Save the Hills" part of our message continues with a vengeance. Many thanks to our loyal friends and members for the continued support of our Legal Defense Fund used to provide legal support for our ongoing activity as Interveners in Landmark Developers attempt to build an outrageous mess in the Hills. See a legal synopsis (right) FYI.

Our other activities continue:

- 1) We together with the Friends of the Oswegatchie Hills Nature Preserve have been working with Audubon Connecticut to have the Hills designated as an Important Bird Area (IBA). The designation depends on the fact that the Hills are recognized as a prime stopover for migratory birds (spring and fall). Thanks to David Hughes of Wild Birds Unlimited in East Lyme for coordinating inputs to the website www.ebird.com, where Birders can post their logs in the internet. (His wonderful little store at 190 Flanders Rd in Niantic is a great gift shop for nature loving folks!)
- 2) We closed the 2013 Pumpout boat season last week. It continues to grow with more boaters each year helping to keep the River clean.
- 3) Our Water Quality Monitoring Program continued with Bacterial Beachwater collection on the Upper River. An extremely dry summer resulted in low to zero reading of Enterococci Bacteria most of the summer underlying our cautions to avoid water contact activity after a heavy rainfall. A full report will appear on our website...
- 4) Our website continues to be an issue. Our URL was taken over by foreign company. So we have moved it to www.savetheriversavethehills.org (no hyphen). If you can help us create our new website, please contact Deb at 860-444-9247. Facebook is up-to-date, "Like" us!

#### **Pumpout Boat Program**

Another successful Pumpout Season came to the end of operations October 31. The boat is being winterized and stored this month. Operations will begin Memorial Day weekend, 2014. We would like to once again thank the towns of East Lyme and Waterford for funding the expenses not covered by the program from the Connecticut Department of Energy & Environmental Protection. Remember that the Niantic River and Niantic Bay and all of Coastal Connecticut remain a No-Discharge Zone.

When winterizing your boat, please ask your marina if they follow "Green Marina" guidelines when cleaning and storing your boat. You can make a difference by asking the question! Also, if you are washing your own boat, wash it over grass so the dirty water doesn't end up in the storm drain and eventually into the River. Every bit counts!

## STR-STH Program Updates...

### Legal Defense Fund — Help Us Save Oswegatchie Hills!

We thought it would be a good idea to give our members a **Legal Case History Synopsis** so we can all understand the history of **Landmark Development**, **LLC's plans for Oswegatchie Hills**:

- Case # 1 Application for 894 units Town denied in 2001; Judge Quinn upheld Town on 9/3/04.
- Case # 2 352 units for "Phase 1" Town denied in 2004. The Friends, Save the River-Save the Hills, Inc. and the Town filed briefs 1/06 opposing Landmark's appeal. Motion by Landmark to overturn the denial by the zoning commission was denied by Judge Elliot Prescott on February 1, 2008.
- Case # 3 840 units "Partially" approved 12/05. The Zoning Commission re-zoned as "Affordable" ONLY the area within the sewer shed and rejected Landmark's proposed text amendments. This action was appealed by Landmark 12/05 and remanded (see status below) to the zoning commission on a 2011 decision by Judge Frazzini. On 3/29/06, the Niantic River Gateway Commission rejected this re-zoning by the East Lyme Zoning Commission.
- Case # 4 1720 units, submitted 1/06. Zoning Commission Public hearing was opened April 6, 2006. Strong testimony was provided by Attorney General Blumenthal and others. Application was subsequently withdrawn by the developer...
- Case # 5- 1720 units if Sewer (or 1548 units if septic). Public Hearing opened on 7/12/07. Strong testimony by AG Blumenthal, Don Gerwick, PE and others. Denied by Zoning Commission, then appealed. Judge Frazzini made some indication that he would like to handle the appeal of Case #4 & 5. This appeal is on hold pending resolution of Case #3.
- 2013 Status Judge Frazzini recused himself; case now with Judge Berger. Landmark has appealed a 2013 denial by the Sewer Commission for capacity for 840 units on the hilltop (as proposed in Case #3). The zoning commission has amended the Affordable Regulations per Frazzini's remand, and a public hearing that was scheduled for 10/17/13 for Landmark's request to rezone the site Affordable was cancelled because Landmark withdrew its application after the Town reminded them that per Frazzini a site plan needed to be submitted first. **December 6th is date of hearing for Water-Sewer appeal**.
