A Message from our Founder & President

Thank you all for your continued support of Save the River-Save the Hills! Seems incredible that we are in our 17th year of advocating for the health and safety of our River and surrounding Hills. For 2018, we are looking forward to a busy season. This will be the second year of our participation in Save the Sound's Unified Water Study of Long Island Sound embayments. We also plan to add a rework of the bacterial study we did 3 years ago. This work was suspended for two reasons: the continuing drought and state budget problems which terminated the free lab work provided by the Department of Health Laboratory in Rocky Hill. We anticipate a reduced coverage study of the river in parallel with the Unified Water Study. STR-STH will have to pay lab costs because of the lack of state monies. But we are looking forward to resuming these studies of the Niantic River this Spring.

Some good news: 1) We have hired Suzanne Thompson part-time to help keep our studies going and to kick-start a Watershed Education Program (see page 2). We are waiting to hear about a grant she has applied for. Stay tuned on that! Plus, 2) we are preparing a new (to us) pumpout boat to replace the 14 year old Carolina skiff. The CT Department of Energy and Environmental Protection (DEEP) has arranged the donation of a 2 year old boat to our program. We are in the process of checking it all out and getting ready to launch the 2018 pumpout program that starts on the Friday before Memorial Day. The pumpout boat will be working on the Niantic River each Friday—Monday from May 25th through Labor Day weekend, then Saturdays & Sundays through November 1st. Spread the word!

STR-STH Program Updates:

Legal Defense Fund — Help Us Save Oswegatchie Hills!

CFE continues to represent us in ongoing legal battles to protect and preserve the remaining 236 acres of undeveloped, unprotected Oswegatchie Hills directly adjoining the existing OHNP.

Roger Reynolds, CFE Chief Legal Director, provides us these Legal Updates:

1) Zoning appeal to Superior Court

"After over a year of inactivity on this case, the Court held a status conference on November 27, 2017, in which the Court addressed Landmark's anticipated response to CFE's motion to dismiss the appeal. Follow-up telephone conferences were held in December, January and February with the judge. No further calls are scheduled and we expect a decision on our motion to dismiss Landmark's appeal in the next several months."

2) Sewer Appeal to Appellate Court

"The sewer appeals (both our appeal and East Lyme's appeal) have just been scheduled to be argued in the Appellate Court before the panel of Judges DePentima, Alvord and Bear on April 10, 2018. The case is fully briefed. We will argue that in overturning the Sewer Commission's decision to limit the amount of sewage capacity granted to Landmark, the Superior Court judge improperly usurped East Lyme's authority to make decisions on allocation of this scarce and environmentally important resource. The cases are A.C. 39804 and 39806. The two appeals are the second and third cases in the morning session. Arguments take place at the Appellate Court at 75 Elm St in Hartford and are open to the public."

STR-STH and The Friends of the Oswegatchie Hills Nature Preserve will have representatives attending the hearing in a show of support for the town's Water/Sewer decision. This will be a big decision in our many year quest to Save the Hills! Please remember that STR-STH is paying for Roger's expertise when you send in your membership renewal this year!

Watershed Education

We have applied for a Community Foundation of Eastern Connecticut (CFECT) Environmental Grant to support our Watershed Education program. The Niantic River Watershed Behavior Change proposal engages science students at the 3 public high schools in the watershed – East Lyme (including Salem), Montville and Waterford, in spring and fall workshops to research and explore the topic and to develop small public outreach campaigns over the summer. Fall science classes will again pick up the program and topic, and East Lyme HS will host a workshop where students can present their papers, posters and findings. The long-term plan is for this watershed-based collaboration to be incorporated into the schools' science/environmental classes and clubs. Wish us luck on getting the Grant!!!

Pumpout Boat Program

We will start our 16th season of the Pumpout Program Memorial Day Weekend. The boat is available Friday through Mondays from Memorial Day to Labor day, then Saturdays & Sundays until Nov 1st. Spread the word—the Niantic River and the entire Long Island Sound is a No-Discharge Zone by order of the U.S. Environmental Protection Agency. Our Pumpout Boat can be contacted by calling the cell number for the boat: 860-287-2774 (phone). Many thanks to the State of CT DEEP and the towns of East Lyme and Waterford for fully funding the pumpout program! We pay are able to pay our hardworking deck hands though the grant, but tips are always appreciated!!
